Mr. Shan asked one of his friends to help him buying a desktop computer. The friend gave him three specifications as shown below for a desktop computer and asked him to select one. Now he wants your support to select the right specification for a desktop computer.

2. The Virtual Information Technology University (VITU) is a degree awarding institution. Currently it offers a Bachelor of Science Honours in Information Technology (B.Sc. Hons (IT)) degree. The following admission criteria for this degree was published on their website in an announcement inviting a new batch of students for the degree.

(i) Three passes in one attempt in the physical science stream of GCE (A/L)

OR

(ii) (a) Three passes in one attempt in any other stream of GCE(A/L)

AND

(b) Successfully completed an acceptable foundation course in Information Technology with Mathematics.

- (i) Identify **three** logical connectives and explain their functionalities. (09 marks)
- (ii) Draw a truth table for the above admission criteria. (10 marks)
- (iii) Discuss the suitability of a truth table to represent the above admission criteria. (06 marks)
3. A young farmer who lives near the main road from Colombo to Anuradhapura has decided to sell his vegetables himself to tourists traveling along the road. He has realized that it is essential to inform tourists in advance about the types of vegetables to be sold, their quantities and prices to make this a successful business. He discussed this idea with his daughter who is sitting for GCE A/L this year. She recommended a web-based software application for this. However, she has no idea of how to develop such a web-based system using HTML, JavaScript and MySQL like tools. Still, she has a knowledge about using ICT including mobile applications.
- (i) What is a web authoring tool? Explain. (08 marks)
- (ii) Propose a web authoring tool known to you which can be used for this task and explain how you can develop this application using it. (12 marks)
- (iii) Discuss the advantages of web authoring tools. (05 marks)
4. - (ii) Explain negative impact of e-waste for the environment. (09 marks)
- (iii) Explain how you can manage e-waste using 3R concept (Reduce, Reuse, Recycle). (06 marks)

5. Hewage Associates is a software development company catering for large international companies. When they undertake a system development assignment, they need to continually interact with different personnel in the clients' organization. These interactions can be one-to-one calls, small-group meetings, as well as large group trainings. In the process of system development, the company develops many electronic documents, which are usually confidential. These documents need to be sent to the client in a secure manner. During implementation stage some confidential information such as usernames and passwords also need to be sent in a secure manner. Hewage Associates makes all these communications on-line without any physical interaction.

- (i) Propose a suitable tool to conduct the above mentioned meetings. Justify your answer giving the supportive features of the tool you propose. (10 marks)
- (ii) Discuss different ways to send the electronic documents in a secure manner. (09 marks)
- (iii) What are the methods that you can use to send information such as usernames and passwords securely and quickly? (06 marks)

 - (ii) Draw a sketch of spreadsheet to calculate the monthly income tax for a given total monthly income for tax calculation. Explain the content of each cell in your spreadsheet. (10 marks)
 - (iii) Describe the formatting you applied in the spreadsheet. (08 marks)
7. A school near to where you reside has invited you to give a lecture on "Operating Systems" for their "IT Day". The organizing committee hopes to invite students from other schools in the area to participate. Therefore, the organizing committee has also decided to prepare a book containing the speeches of the guest speakers to be given to all those who will participate on that day.
